Have you heard that the CARE Bill has been introduced in the senate? Senate Bill 3338, the Consistency, Accuracy, Responsibility and Excellence (CARE) in Medical Imaging and Radiation Therapy bill was introduced by Senator Mike Enzi, R-Wyo., and Senator Tom Harkin, D-Iowa, on June 26. Please contact our senators Sherrod Brown and Robert Portman and ask for their support. I also cannot leave this topic without mentioning that the House Bill, HR 2104 has over 125 co-

sponsors to date. I urge all of you to contact your representative if he or she has not signed on as a cosponsor.

Prior to the meeting I had the opportunity to watch the Subcommittee on Health Hearing entitled "Examining the Appropriateness of Standards of Medical Imaging Technologists" via webcast on Friday June 8. Sal Martino, ASRT CEO, provided testimony along with others in support of HR 2104 (CARE Bill). There were several questions asked during the hearing. One question addressed the training of airport personnel and whether the Medicare Improvements for Patients and Providers Act of 2008 could be expanded to include the CARE Bill. I also recommend that you watch for updates concerning the ARRT concerning the new education requirements. Beginning **January 1, 2016,** candidates for post-primary certification will also be required to complete 16 hours of structured education related to the content specifications for that exam. The education must meet the same standards as CE activities in that it must be either RCEEM approved or university awarded. Structured educational activities that are only state-approved will not satisfy the requirements.

# **CARE Bill Introduced in the U.S. Senate**

ALBUQUERQUE, N.M. – The <u>American Society of Radiologic Technologists</u> announced today that the Consistency, Accuracy, Responsibility and Excellence in Medical Imaging and Radiation Therapy bill, S. 3338, was introduced in the U.S. Senate by Senator Mike Enzi, R-Wyoming., and Senator. Tom Harkin, D-Iowa.

The CARE bill would ensure that basic minimum education and certification standards are established as part of the Medicare program for all medical imaging and radiation therapy personnel.

"This is a big step for the CARE bill, which would save the government money and ultimately improve the quality of patient care," said ASRT President Dawn McNeil, M.S.M., R.T.(R)(M), RDMS, RVT, CRA. "We are encouraged that Sens. Enzi and Harkin introduced the CARE bill, and we hope both the House and Senate will take action on the bill this congressional session."

Currently, basic educational standards for medical imaging and radiation therapy professionals are voluntary and inconsistent in many states, allowing some individuals to perform radiologic procedures without any formal education. Six states, along with the District of Columbia, are without any regulations regarding the qualifications of personnel performing medical imaging examinations.

In June 2011, the House CARE bill, H.R. 2104, was introduced by Rep. Ed Whitfield, R-Ky., and now has more than 125 bipartisan cosponsors.

"ASRT members have worked tirelessly to educate their congressmen about the importance of education and certification standards in medical imaging and radiation therapy," said Christine J. Lung, CAE, ASRT's vice president of government relations and public policy. "The long-term efforts of so many dedicated radiologic technologists will finally pay off when the CARE bill legislation is enacted."
