HR 3032: Medicare Access to Radiology Care Act

It is well known that the rising demand and clinical need for timely medical imaging services and the increased complexity of radiologic studies have placed unsustainable pressure on our health care delivery system, limiting access to quality care for all patients. To answer this challenge, the radiologist assistant (RA) was developed by a collaboration of several nationally recognized radiology organizations, to assist radiologist physicians increase the efficiency of the imaging department.

However, currently the RA profession lacks the appropriate recognition by statute and Medicare for needed reimbursement of radiology services provided by the RA. Because of this need for Medicare recognition and associated reimbursement, RA's across the state of Ohio are struggling to attain employment, despite a dire need for their specialized skill-set.

To overcome this hurdle and promote acceptance of the RA profession across the country, House Bill 3032, "Medicare Access to Radiology Care Act" has been introduced to amend the Social Security Act. The bill will direct CMS (Center for Medicare Service) to recognize the Radiologist Assistant and Radiology Practitioner Assistant as direct patient care mid-level providers and refer to individual state licensure to define supervision levels and scope of practice. The bill will also reduce the physician's professional component of reimbursement to 85% of the Medicare Physician Fee Schedule (MFS) while not affecting the hospital's technical component.

Passage of HR 3032 would help to create an environment much more accepting of the RA profession, and perhaps more importantly, provide timely access for radiology patients while enhancing quality of care.

For this reason, the OSRT is actively supporting legislative efforts to endorse HR 3032, and is encouraging all members to contact their respective congressional representatives in support of this bill.
