OSRT ADVOCACY IN THE LEGISLATIVE CORNER

-Proposed amendments to Radiologic Licensure Rule 3701-72-04 of the Ohio Administrative Code are posted for public comment. These proposed amendments were reviewed by the Radiation-Generating Equipment Committee (REC) and other members of the public attending the REC meetings. Please review the rules and provide any comments that you may have to the Ohio Department of Health at ODHrules@odh.ohio.gov by July 10, 2016. The draft proposed amendments to the rules can be found at http://www.odh.ohio.gov/en/rules/drafts/3701-72.aspx

-The U.S. Department of Veterans Affairs has introduced a proposal that would allow nurses to, "Order, perform, supervise, and interpret laboratory and imaging studies." The ASRT strongly opposes this measure as only registered radiologic technologists should perform procedures that use ionizing radiation. Certified nurse practitioners do not have the education, experience or skills required to perform highly technical procedures like x-ray, computed tomography, nuclear medicine, vascular-interventional or bone densitometry. This proposal is a threat to patients and registered radiologic technologists.

The OSRT encourages all radiologic technologists to join in our effort to oppose this shortsighted proposal. Please submit your comments to the federal government and let them know that you strongly oppose the VA's efforts to bypass patient safety measures by allowing nonqualified certified nursing professionals to perform medical imaging procedures. Hello Everyone! For those of you who are on summer vacation from summer classes, I hope you are all enjoying your break, and for those of you, like myself, who don't, I hope you are continuing to learn and work hard toward the Radiologic Technology degree that we're all striving for! Whatever the case may be, summer break or otherwise, there are two events taking place this summer that I would like to share with all of you.

Firstly, I am thrilled to report that I attended the ASRT Annual Governance and House of Delegates Meeting June 24-26 at the Tropicana hotel in Las Vegas, Nevada. I witnessed the hard-working professionals on the forefront of radiology on the national level so that I am able to report back to Ohio students. The ASRT website describes, "The ASRT House of Delegates meets annually to debate and vote on motions and proposed changes to the ASRT Bylaws and to adopt clinical practice and educational standards. During the meeting, delegates' primary duties are to represent the radiologic science profession and their affiliates or chapters and to take action on issues that affect professional practice."

This brings me to the second issue at hand: the Department of Veterans Affairs is proposing an amendment that would allow advanced practice nurses to "order, perform, supervise, and interpret laboratory and imaging studies". This means that certain nurses could both perform and interpret x-ray, CT, MRI, mammography, DEXA, exams and more without the level of training that radiologic technologists undergo to ensure the safety of our patients, the quality of our diagnostic images, and the proper use of ionizing radiation. I am personally urging all of you to write a short statement of opposition explaining why you disagree with the amendment. If enough opposition is not submitted by July 25, 2016, the amendment may pass and could have massive ramifications to the security of our jobs and the future of radiology as we know it. The instructions for submitting a statement are as follows:

- 1) Go to: www.federalregister.gov
- 2) At the top right you will find a "Search Documents" search bar, search for "Advanced Practice Registered Nurses"
- 3) Click on the first link that the search returns (Dated 5/25/2016)
- 4) Take a moment to read over the amendment. Then, at the top right of this page, click the green button that reads "Submit a Formal Comment"
- 5) Enter your personal information as well as your comment of opposition. Submit.

Although we are only students, we must help protect the profession that we will one day call our own, and the patients who undergo radiologic imaging studies. Please take the time to aid in the fight! Submit a statement of opposition, and enjoy the remainder of your summer!
