## ADVOCACY DAY AT THE STATEHOUSE

On Wednesday, May 10, 2023, several OSRT members met with several senator legislative aides. We introduced the OSRT organization, explained who radiologic technologists are, the rigorous education requirements, why imaging professionals should be categorized as essential healthcare workers, the very important role they play they play in a patient's diagnosis and treatment, and the commitment to delivering quality patient care to all individuals. During these meetings, an infographic was handed out, summarizing all these vital points. The legislative aides were interested in learning about the profession, taking copious notes, and asking pertinent questions. While no specific legislative issues were addressed, OSRT members in attendance relayed their passion for the profession and demonstrated that we are the experts in the field of medical imaging.

### **HOUSE BILL 33**

For several years, the OSRT and the Ohio Radiological Society (ORS), have been working together to combat the encroachment of other healthcare professionals and to uphold Ohio's strict radiologic technology licensure laws. In June, while the House and Senate were working on the State Budget that had to be signed by the governor, by July 1st, a proposed amendment was introduced into the bill. If passed inside the bill, the amendment would allow general x-ray machine operators (GXMOs) to perform radiologic procedures under general supervision rather than direct supervision as required by current law.

As soon as the amendment was proposed, the OSRT and ORS went straight to action to have the amendment removed from the budget bill before the governor signed it. The OSRT adamantly opposed the amendment and called on Senators. Dr. Julie Gill provided compelling testimony in front of the Senate Finance Committee. With the ASRT's resources, the OSRT activated a call to action, encouraging technologists to send letters opposing the amendment to their legislators. The efforts of the individuals and organizations were highly successful in removing the amendment from the Budget Bill, keeping direct supervision for the GXMO intact.








## Meet Paul Kudlak: OSRT's Legislative Consultant

His duties include monitoring for proposed and introduced legislation that may affect radiologic and imaging professions. The OSRT is very fortunate to have Paul in this role. He has been an asset to the organization, learning about and monitoring issues or regulatory changes that could harm the profession. He has helped us combat the encroachment of other healthcare professionals into our profession. Over the years, as a consultant for different



entities, he has built strong relationships with Ohio legislators, lobbyists, and other organizations, such as the Ohio Radiological Society (ORS) and the Ohio Department of Health (ODH). While Paul is not a Radiologic Technologist, over the years, since consulting for the OSRT, he has strived to learn about not only the imaging profession but the registered technologists performing these procedures and the patients we diagnose and treat each day. Paul effectively and efficiently communicates with the Advocacy Committee and OSRT board members, attending most OSRT board meetings and providing detailed reports of issues affecting our profession.

Without Paul's diligence on the part of the OSRT, we might not have been as successful at combatting encroachment, rebuilding our relationship with ORS, and passing the mammography tomosynthesis legislation. The OSRT is extremely lucky to have Paul as a watchdog for patients, medical imaging professionals, and the profession of radiologic and imaging sciences.

# OHIO DEPARTMENT OF HEALTH (ODH)RADIATION GENERATING COMMITTEE (REC) AND RADIATION ADVISORY COUNCIL (RAC)

These multi-constituent committees have representatives from radiation physicists, radiologic technologists, physicians, radiation therapists, etc., working with the X-ray Division of the ODH to help regulate licensure, radiation-generating equipment, and enforcement of safe practices of radioactive materials in Ohio.

The OSRT has members on both committees, providing input on safe radiation practices and licensure. OSRT Advocacy Committee members are notified and attend meetings at the Ohio Department of Health. Committee members in attendance report back to the OSRT board of directors, the advocacy committee, and our Legislative Consultant, Paul Kudlak. We discuss the information, and position statements or input is given when appropriate.
